I, _____, Date of Birth, _____ a graduating senior at Kennett High School plan to attend Project Graduation 2018 on June 15th.

I understand that the Project Graduation Committee will be responsible for the following items:

- All meals, snacks and beverages for the duration of the trip.
- All expenses related to the trip, beyond the initial \$50 registration fee.
- Chaperones and Volunteer Nurse for the duration of the trip.
- Storage and administration of all prescription medicine.
- All transportation between venues.

I understand that I am responsible for the following items:

- I will arrive at KHS through the doors near the flagpole no later than 4:00 pm on June 15th.
- I am permitted to bring one carry-on bag with personal items and will drop off the bag for inspection by Project Grad volunteers *in the cafeteria at 8:00 am* when I arrive for graduation on the morning of June 15th.
- I will check in all prescription medicine with the Project Grad nurse at the same time as bag drop off and inspection on June 15th (original container clearly marked with name of student, name of medicine, dosage and frequency, accurate and up to date. Please send *only* amount needed for the duration of the overnight trip. Students may carry their own prescribed inhalers and epi-pens, but please inform the nurse of items carried. Do not send over the counter medication unless your child requires something other than listed).
- I understand the following items will NOT be permitted:
 - Any liquids (water, soda, perfume, coffee, smoothies, etc.) An EMPTY water bottle will be permitted.
 - Food. Special dietary needs may be communicated to the nurse on staff PRIOR to June 15th.
 - Weapons, to include swiss army knives or knives of any kind, and fireworks.
- I am permitted to bring the following items as needed:
 - Personal care items, make up, pens/pencils, phones, reading material, travel pillow.
- I agree to honor the same Code of Conduct listed in the KHS Handbook
- I agree to honor the chemical free rule for this trip. I will not carry with me or use any chemical substances, including Tobacco, Alcohol or Drugs/Drug paraphernalia before or during the Project Graduation trip.
- I agree to follow the school dress code when departing Kennett for the event. I will pack layers of clothing, socks and athletic shoes for planned activities and weather conditions
- I agree to attend the ENTIRE DURATION of the overnight event and travel on authorized vehicles only (unless there is a medical emergency).
- I agree to stay within the designated locations of activities planned for the duration of the trip.
- I will be picked up by _____ (a parent or designee) on the morning of June 16th at 8:00 am and driven home. NO vehicles are allowed to stay in the KHS parking lot overnight, per school policy.
- I agree to assume full risk and to waive, relinquish and release all claims I have against, indemnify, hold harmless and defend SAU9, SAU13, Kennett High School and the Project Graduation Committee organizers and volunteer chaperones.

Infractions of this agreement may result in dismissal from the trip. Families will be responsible for pickup and transportation home from the venue location in such a case.
